

**SUMMARY ANNUAL REPORT**  
**for**  
**VERMONT LAW SCHOOL LIFE AND DISABILITY PLAN**

This is a summary of the annual report for VERMONT LAW SCHOOL LIFE AND DISABILITY PLAN, 23-7251952/503/ Life insurance, Accidental death & dismemberment (AD&D), Temporary disability and Long-term disability for the period 1/1/2016 through 12/31/2016. The annual report has been filed with the Employee Benefits Security Administration, formerly known as the Pension and Welfare Benefits Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The plan has a contract with STANDARD INSURANCE COMPANY to pay all (Life insurance, AD&D, Temporary disability, and Long-term disability) claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2016 were \$84,958.

Because the contract with STANDARD INSURANCE COMPANY is a so-called experience-rated contract, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2016, the premiums paid under the experience-rated contract were \$84,958, and the total of all benefit claims paid under the experience-rated contract during the plan year was \$162,059.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes, if any, will be included as part of that report. The charge to cover copying costs given above does not include a charge for copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan at P.O. BOX 96, SOUTH ROYALTON VT 05068-0096 and at the US Department of Labor in Washington DC, or obtain a copy from the US Department of Labor upon payment of copying costs.
