

SUMMARY ANNUAL REPORT

This is a summary of the annual report of the VERMONT LAW SCHOOL HEALTH & WELFARE BENEFIT PLAN, EIN 23-7251952, Plan No. 510, for period 01/01/2021 through 12/31/2021. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with CIGNA HEALTH AND LIFE INSURANCE COMPANY, VISION SERVICE PLAN, and UNUM LIFE INSURANCE COMPANY OF AMERICA to pay Medical, Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Critical Illness, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2021 were \$677,935.
